# [Notice] Policy on COVID-19 effective immediately after the change in its legal status under the Infectious Disease Act (effective on or after May 8, 2023)

The University's precautionary guidelines against COVID-19 and its spread have been set forth based on the Basic Response Policy and other measures by the Government of Japan pursuant to the Act on Special Measures against Novel Influenza, etc. (Act No. 31 of 2012). Based on the fact that the classification of COVID-19 under the Infectious Disease Act is downgraded from Novel Influenza Infection, etc. to Class V infectious disease as of May 8, 2023, the University has resolved to move its Alert Level from Level 1 to Level 0 prescribed in the Hokkaido University Business Continuity Plan During Coronavirus Outbreak (hereinafter referred to as the "BCP") and terminate the BCP.

The following is the policy on COVID-19 effective immediately after the change is made in its legal status under the Infectious Disease Act. Please act accordingly.

The COVID-19 Task Force shall be maintained for the time being, and in the event of unforeseen circumstances, the Task Force will respond appropriately.

# 1. Response to COVID-19 Cases

- There are no reporting of new cases and no work restrictions.
- The University no longer determines the number of cases within the University nor discloses such information.

# 2. Precautionary Actions

 As a general rule, the University does not mandate universal precautions for infection control and leaves it to the discretion of each individual, school, faculty, institute, etc.

- Mask wearing shall be optional, and based on individual preference. Wearing a mask is recommended in situations where it is effective in preventing infection, such as when using public transportation during the commute or when visiting medical or elderly care facilities.
- Avoiding 3Cs (Closed spaces, Crowded places, and Close-contact settings), practicing social distancing, cough etiquette, and hand hygiene including thorough hand washing, as well as ensuring good ventilation are recommended since they are effective in preventing common infectious diseases.
- All members of the University are expected to proactively manage their health. In
  the event of contracting COVID-19, the law does not require to stay home. As a
  general rule, whether or not to stay home shall be at the discretion of the individual.
  Refer to the period of isolation recommended by the Ministry of Health, Labor and
  Welfare as guidance. \*
  - \* The Ministry of Health, Labor and Welfare recommends that those who have contracted COVID-19 should stay home until five days have passed since the onset of symptoms, counting the day of onset as day 0, and until 24 hours have passed after symptoms have subsided.

# 3. Research Activities

Appropriate decisions shall be made by comprehensively considering the following for each case: the local pandemic situation, the field and methods of research, financial damage incurred to or importance of the research, risk of developing a serious illness for the people involved, etc. The latest information on the methods and modes of research shall be taken into account as well.

# 4. Classes (lectures/seminars/experiments/hands-on training)

- In principle, all classes are conducted in person. Alternative options must be provided to students who missed classes due to unavoidable circumstances, such as contacting COVID-19.
- Admissions shall be conducted in accordance with the notification of the Ministry of Education, Culture, Sports, Science and Technology, etc. The exact method of implementation shall be described in the application guideline. The procedures may change depending on the pandemic situation or other reasons. In such cases, it will be promptly announced both inside and outside the University.

# 5. Student Extracurricular Activities

- There are no restrictions on student extracurricular activities or the use of extracurricular facilities.
- When engaging in extracurricular activities, including travel and meetings involving food and beverages as a student group, "2. Precautionary Actions " shall be noted.

# 6. Work Arrangement

 Regular work schedule; no remote work or staggered work hours are implemented due to COVID-19.

# 7. Meetings (including trainings/workshop/orientation)

- There are no restrictions on organizing and hosting conferences, trainings, workshops, etc. due to COVID-19.
- o In accordance with the "Guidelines for the Use of Web Conferencing 「Web 会議 活用ガイドライン」" as of November 9, 2021, meetings at the University shall be in principle held online, in order to improve efficiency and speed of operations, including accommodating various work styles, reducing travel costs, etc.

# 8. Campus Visits by Non-University Members

• There are no restrictions on campus entry due to COVID-19.

### 9. Other

- The University Libraries shall be open under the generally recommended infection control measures.
- There are no restrictions on organizing and hosting events, etc. due to COVID-19.
- There are no restrictions on medical care at the Health Care Center due to COVID-19.
- There are no restrictions on the use of Student Advice and Counseling Center due to COVID-19.
